VFW National Programs Report

In observance of the centennial of World War I, a total of 100 matching grants of up to \$2,000 each will be awarded for the restoration of 100 World War I memorials across the United States. The first 50 of these were announced on Sept. 27, 2017, and the second 50 will come from the second round of the matching grant challenge.

Any municipal government, individual or organization may apply. Likewise, any individual, organization or company can become a sponsor of this effort, because the more we raise toward this program, the greater the matching grants can be awarded.

Interested parties should go to <u>ww1cc.org/100memorials</u> where they can learn about the details of the program, read or download the competition manual, submit a grant application and sign up for an informational blog about the program that will keep them updated over the coming months.

We have a lot to be thankful for this year. First and foremost, VFW Unmet Needs has delivered nearly \$9 million in financial grants. Second, we have eclipsed 900 VFW's "Sport Clips Help A Hero Scholarships" totaling just over \$4 million. And rumors are, next week, Sport Clips will present a record-breaking \$1.25 million dollar donation to the program.

We could not have the incredible impact on veterans, service members and their families without the support of Burger King & Sport Clips. This is why we have asked those of you with participating franchises to go out and show them our support, thank them and continue to build the relationship!

We have seen an increase in holiday party support through MAP grants for our adopted units. We salute you for pushing the incredible support to our military and their families during the holidays.

Tax relief for elderly and disabled residents of Prince William County

Elderly Citizens and Disabled Persons who meet certain criteria may be granted relief from all or part of their real estate taxes, personal property tax on one vehicle, the vehicle registration/ license fee, and the solid waste fee. Eligibility criteria may change from year to year.

To qualify, an applicant must:

- Be 65 years of age or older as of December 31, 2017. Relief will be prorated for those applicants that turn 65 during calendar year 2017.
- Have a gross household income from all sources of not more than \$81,490 - The first \$10,000 of income earned by any relative living in the household other than the owner(s) or spouse is excluded. For an applicant who qualifies as permanently and totally disabled, the first \$7,500 of any income received by the applicant as permanent disability compensation is excluded.
- Have a combined financial net worth for the applicant and spouse of not more than \$340,000, excluding the residence for which the exemption is sought and up to 25 acres of land it occupies.
- Own and occupy the home as his/her sole dwelling.

Disabled veterans who meet certain criteria may be granted relief from real estate taxes on a home and up to one acre of land it occupies and the solid waste fee. Relief will be prorated for applicants who become disabled or purchase a home after January 1, 2017.

Eligibility criteria for relief of real estate taxes and the solid waste fee:

- The applicant must provide documentation from the U.S. Department of Veterans Affairs (VA) indicating the veteran is 100% (or compensated at the 100% rate), serviceconnected, permanently, and totally disabled. The VA documentation must include the effective date the veteran's disability was determined to be service-connected, 100% (or compensated at the 100% rate), total, and permanent.
- The applicant must own and occupy the home as his/her principal place of residence.
- There are no income or net worth requirements for real estate tax relief for qualifying disabled veterans.

The surviving spouse of a veteran eligible for the real estate exemption may qualify for the exemption if:

- The death of the veteran occurred on or after January. 1, 2011.
- The surviving spouse does not remarry.
- The surviving spouse continues to occupy the real property as his/her principal place of residence.

VFW Parliamentary Authority

The 2018 VFW Procedures and Rituals approved at the 2017 National Convention establishes *Robert's Rules of Order, Newly Revised, 11th Edition* shall be the parliamentary authority on procedural matters not governed by VFW By-Laws and Manual of Procedure.

This obsoletes *Demeter's Guide to Parliamentary Procedure* that the VFW has previously used. The reason for the change is Demeter's had not been updated since the 1960s and had no provisions for dealing with technology changes that have occurred since that time.

This change brings the VFW in line with almost every other organization that uses parliamentary procedures.


