1. New Appeals Process Launched This Week: On Tuesday, VFW Washington Office Executive Director

Bob Wallace, National Veterans Service Director Ryan Gallucci, Training & **Ouality Assurance Manager Lauren** Barefoot, and Retired National Veterans Service Director Jerry Manar joined senior VA officials at VA central office for the kickoff of the new and improved appeals process. Starting this week, all veterans who disagree with their VA rating decision will have three new options to resolve their benefit disputes: request a higher-level review from a more experienced person, submit a supplemental claim with additional evidence, or appeal directly to the Board of Veterans' Appeals. Over the past four years, Mr. Manar and Ms. Barefoot have represented the VFW in negotiations with Congress, VA, and other veterans' organizations to craft this new framework. The goal of the new process is to offer veterans greater flexibility and transparency to resolve benefit disputes in a timely manner, instead of waiting years for VA to adjudicate their appeals. The VFW will monitor the implementation and work with VA to resolve any issues that come up. For assistance appealing a decision on your benefits claim, contact a highly trained and accredited VFW Service Officer.

2. Bill to Increase Veterans in Infrastructure Introduced: Senators Gary Peters and John Cornyn recently introduced S. 492, the Disabled-Veterans Rebuilding Infrastructure to Vitalize our Economy (DRIVE) Act, which would create a goal that five percent of the federal funding for infrastructure projects be granted to service-connected disabled veteran owned small businesses (SDVOSBs). The VFW-supported DRIVE Act would increase SDVOSB's ability to compete for infrastructure contract. 3. VA to Implement Appeals Modernization Act Next Week: Beginning Feb. 19, all veterans who disagree with their VA rating decision with have three new options to resolve their benefit dispute: request a higher-level review from a more experienced person, submit a supplemental claim with additional evidence, or appeal directly to the Board of Veterans' Appeals. Over the past two years, the VFW worked closely with VA and other veterans' organizations to craft this new framework, which was authorized by the VFW-supported Veterans Appeals Improvement and Modernization Act of 2017. The goal of the new system is to offer veterans greater flexibility and transparency to resolve benefit disputes in a timely manner, instead of waiting years for VA to adjudicate their appeals. 4. VA to Implement High Tech Training Program: In anticipation of launching the Veteran Employment Through Technology Education Courses (VET TEC) program in April, VA is seeking training providers to help implement this new training course. The VET TEC program will provide training on information technology, computer software, information science, media application, data processing and computer programming fields. The VET TEC program was part of the VFWsupported Forever GI Bill that made sweeping reforms to education and training programs for veterans. Learn more or apply for the VET TEC program.

5. VA to Receive Three New Fisher Houses: VA announced yesterday that it is scheduled to receive three new buildings from the Fisher House Foundation. The new facilities will be in Ann Arbor, Mich., Aurora, Colo., and Omaha, Neb. The Fisher House Foundation donates housing facilities to VA and the military to act as a "home away from home" for active duty military, veterans, and their families when receiving treatment at a VA medical facility or major military installation. These facilities are located within walking distance from treatment facilities and provide cost-free housing. Currently, there are 80 Fisher Houses around the world — 38 are located next to VA facilities. An expansion from 38 to 64 is planned over the next few years. Read more about VA Fiher Houses.

6. WASHINGTON (February 14, 2019) -In advance of the Administration's budget request for fiscal year 2020 and advance appropriations for FY 2021, the three coauthors of The Independent Budget (IB) - Veterans of Foreign Wars of the U.S., Disabled American Veterans, and Paralyzed Veterans of America - today recommend a total of \$103.3 billion to ensure the Department of Veterans Affairs begins to fully and faithfully implement the VA MISSION Act of 2018, make needed improvements, and is able to timely deliver benefits and services to wounded, ill and injured veterans, their families and survivors. This is the first time the IB's recommended budget has topped the \$100 billion mark and represents a 17 percent increase over current FY 2019 funding.

Implementing the VA MISSION Act this fiscal year will require significantly more resources than have been provided through regular appropriations and is the main reason why medical care appropriations for FYs 2020 and 2021 need to be increased. The law, which changes how VA provides health services for veterans in the community, is projected to increase veterans' enrollment in the VA health care system and increase veterans' utilization and reliance on VA as a direct provider of care.

Other highlights from The Independent Budget funding recommendations for FY 2020 include:

\$70 billion for veteran's medical care funding, a \$3.5 billion increase over FY 2019;

\$18 billion for medical community care funding, nearly doubling the FY 2019 appropriation;

\$6.1 billion for information technology (IT), \$1 billion more than FY 2019 funding level; and

\$2.7 billion for VA major and minor construction programs to repair, renovate, expand and replace VA's aging infrastructure, a \$1.8 billion increase over FY 2019.

"We appreciate that Congress remains committed to doing the right thing and has continued to provide increases in appropriations dollars," the three IB coauthors state. "However, the serious access problems in the health care system identified in 2014, and the enactment of the VA MISSION Act to provide greater access to community care through an integrated, high performing network, as well as improve and expand other VA programs and services — has created a financial obligation that, absent sufficient resources to fully and faithfully enact this

The IB recommends \$18.1 billion for the Medical Community Care account for FY 2020, which includes \$8.5 billion to meet related requirements in the VA MISSION Act, including replacing the Veterans Choice Program with the new Veterans Community Care Program by the start of FY 2020, and implementing the new Urgent Care benefit and Veteran Care agreements.

Additionally, the IB is calling for a \$1 billion increase in IT funding over FY 2019, citing concerns with VA's ability to deliver timely, effective and efficient IT solutions that can sustain current operations delivering benefits and services to veterans, support continuous

Veterans overseas and are good for six months after the expiration date here in the US. This coupon drive helps our Veterans save funds while they are away from home.

# Mentors needed for Veterans' Docket

The Prince William County Veterans' docket was developed to give veterans who have been charged with a criminal or serious traffic offense the opportunity to seek and participate in service connected treatment or other services that address service connected issues which led to the current pending charges.

Veterans would be allowed to participate in relevant services prior to final disposition of their charges. The docket is operated on the assumption that meaningful participation in service connected treatment programs will ultimately lead to the best possible outcome of the pending charges. A mentor program staffed by veterans is being developed to help guide participants through the process.

There is a need for veterans to volunteer as mentors. The Veterans' docket is held every 4th Monday at the courthouse in



On June 6, 1944 Bedford, Virginia lost 20 of the 32 sons it sent to the invasion of Normandy, a devastating blow to the tiny community of just over 3,200 souls. Over time, grief gave rise to solemn pride and deep commitment to ensuring the story of D-Day and its costs and consequences were not lost on future generations. That commitment, along with the distinction of sustaining the highest per capita D-Day losses, placed the monument to D-Day here rather than elsewhere in the country. Dedicated in 2001 with some 24,000 in attendance, the Memorial has since hosted hundreds of thousands of visitors from around the globe.

The Memorial's motto – "Commemorating Their Valor, Fidelity, and Sacrifice" – places education squarely at the center of its mission and "The Final Salute," the 75th anniversary of D-Day, promises to be the Memorial's biggest educational undertaking yet, and its largest event since the national dedication in 2001.

"The Final Salute" combines the best of the Memorial with the best of the D-Day story: a gathering of veterans and the general public at the nation's memorial to the invasion of Normandy for reflection and remembrance – the story of ordinary people in extraordinary moments.

June 6, 2019 marks the 75th Anniversary of D-Day, a milestone that is expected to represent the last large gathering of D-Day veterans around the globe. The youngest D-Day vets are in their middle-90s; a few more years will find the last of them gone from us. To mark this milestone and take advantage of the opportunities for discussion and commemoration it presents, the National D

### VHP Web Feature Explores Impact of GI Bill

The Library of Congress Veterans History Project (VHP) last week launched "The GI Bill: 75 Years of Opportunity," an online Experiencing War website feature that explores the impact of the GI Bill on 15 veterans interviewed for the VHP collection.

The Servicemen's Readjustment Act of 1944, colloquially known as the Gl Bill, was a landmark piece of legislation that offered educational benefits, low-cost mortgages, low-interest business loans and unemployment benefits to returning World War II veterans.

In the 75 years since its passage, the transformative potential of the Gl Bill has continued – the legislation has provided economic and educational opportunities to generations of veterans.

One veteran highlighted in "The GI Bill: 75 Years of Opportunity," is John William Warner, former Secretary of the Navy and former five- term senator from Virginia. As both a World War IINavy veteran and a Korean war Marine Corps veteran, warner used the G l Bill to earn his college and law school degrees. During his 2005 VHP oral history interview, he credits this revolutionary legislation for his political success, saying, "If it hadn't been for [his military training] and the GI Bill, I wouldn't be sitting here in the United States Senate today. It's as simple as that."

Two months and 17 days after the terrorist attacks of Sept. 11, 2001, Missouri native Kara Ann Kittrell joined the Army, hoping to be deployed to Iraq, where she could do her part on behalf of her country. After serving, Kittrell went on to use the Gl Bill to earn a degree in international business.

Another collection tells the story of Ralph Pyle, a World War II veteran who also served as a Signal Corps photographer during the Korean war. Pyle purchased a home using the G1Bill and also obtained his pilot's license.

- If you have a Department of Defense ID (CAC, retiree, or dependent card) you may enter via the Henderson Hall (Gate 1) or Wright Gate (nearIwo Jima).
- Everyone may enter through the **Hatfield Gate** with valid photo ID. Please allow extra time to clear security.

#### Your entire party may not be allowed to enter JBM-HH if one or more of you does not have a valid photo ID.

#### TICKETING

All seating is General Admission, which means that none of these tickets is for an assigned seat. Patrons with tickets are seated on a first-come, first-served basis starting at 1 hour prior to show time; we ask that you are in your seats no later than 2:45 p.m. at which time, if you have a DoD ID, patrons may walk-in without a ticket if there are seats available.

#### VENUE and PARKING

Located on the Fort Myer side of Joint Base Myer-Henderson Hall (JBM-HH), Conmy Hall is the indoor parade facility where many important military ceremonies and awards are presented. 
