## Service Officer's Report



Hello Comrades,

It is time to submit for your annual clothing allowance with the Department of Veterans Affairs (DVA). If you use and/or continue to use a prosthetic or orthopedic appliance (Example: knee or back brace) or medication because of a service-connected disability, and its use results in damage to your clothing, you should:

- Complete VA Form 10-8678, Application for Clothing Allowance
- Identify on the form each appliance or medication you use because of a service-connected disability that results in damage to your clothing, and
- Immediately submit the complete form to the Prosthetic and Sensory Aids Service (121), at your local DVA Medical Center (VAMC).

The event will be broadcast live, and VFW Posts are encouraged to share in the commemoration by hosting "Pancakes for Patriots"-type events to honor and help educate local communities about the service and sacrifices made by so many of our VFW members and their families. The current June/July issue of VFW Magazine is dedicated to Korean War veterans, plus highlights our \$600,000 donation towards building their national memorial---tops among all veterans' organizations. ## Stolen Valor Act headed to President

The VFW is applauding Congress ... for passing the Stolen Valor Act of 2013, introduced by Rep. Joe Heck and Sen. Dean Heller, both from Nevada. H.R. 258 was passed overwhelmingly in the House on Monday [May 20] by a vote of 390-3, and the Senate passed its companion, S. 210, Wednesday night [May 22] by unanimous consent. The legislation now heads to the White House for the president's signature. VFW National Commander John Hamilton said Congress followed the roadmap laid out by the U.S. Supreme Court when they overturned the original Stolen Valor Act last year. In their writings, the high court suggested any future legislation had to be narrower in focus than just to penalize people for simple lying, which they ruled as protected speech in a 6-3 decision. "Now the new language is bullet-proof," said Hamilton, "because the focus is on the intent to profit from the lie, to obtain

money, property or something of a tangible benefit, which is what combat artists have been doing throughout history.” Not every combat award is covered, but the ones most worn by wannabe heroes will be protected once the bill becomes law. VFW advocates were able to reach all 100 Senate offices in record time after the House passed their bill, encouraging the Senate to take action. ## Comrade receives award after 43 Years

It was 14 June 1970 on Firebase David in the Republic of Cambodia at 0300 hrs. I was a platoon leader with the 1<sup>st</sup> Air Calvary Division and charged with defending four bunkers on the perimeter. One of the multiple trip flares my guys had put out went off and the guard on duty fired a single shot at what he saw move, but there was no return fire. We went to 100% alert and attempted to search the area but dense fog obscured our vision and no further sightings could be made under mortar illumination for nearly half an hour. However, one of my guys standing next to me spotted something and pointed to it saying it looked like an NVA and suddenly said "he's going to shoot"! All I saw was the muzzle flashes but he had aimed too low and the rounds skimmed off the berm and grazed my head. The wounds were not serious but I was bleeding badly, so I ran to my bunkers checking my men and got on the radio to call in the preplanned mortars. Then I called my CO and gave him a report of the firefight that had erupted in my sector when a Chinese grenade blew me to kingdom come with nearly fatal injuries. I lay near death for nearly 2½ hours as the battle for the firebase raged until dawn and the enemy retreated leaving 28 KIA. My guys did a wonderful job that night and we lost zero KIA with 26 various wounded beating the NVA best at their own game. Unfortunately, due to the severity of my injuries from the grenade, I was unable to run the victory lap as the enemy withdrew and the sun came up, but I smile today when I read the after-action report from the Daily Log. My guys did good.

Five years ago I attempted to contact various Army Agencies to investigate the award of an Oak Leaf for my Purple Heart. I was told I needed two eye witnesses or a Doctor's report to substantiate the claim which I did not have. I wrote letters, and waited six months at a time only to receive negative responses with misinformation, lost records and just being ignored. A Senate inquiry rattled swords but got no action. Sometimes my inquiries were directed to the wrong Agency or Department, but they never bothered telling me they had no authority in the matter, so I just spun my wheels in six month intervals or more without making progress. While my evidence did not fit the perfect mold for the award,

With flash drives we should be able to go into schools around Veterans Day or at other times in the school year and have three VFW members in three different classrooms showing the presentation. That is the hope anyway. This is also something we could show to scouting groups or other youth organizations that might visit the Post Home. The total running time for the presentation is between five and ten minutes. The person showing it can read the narrative but we also hope to produce a recorded version. There is time for questions at the end. When we have a final finished product we will email it to each committee member and also show the finished product at a monthly Post membership meeting.

I want to thank both Dawn Schueller Moore and Rick Raskin for their work with the committee on Thursday night and Dawn for her work on

this project over the past several weeks.

Committee members Pete MacLeod and Robert Punihaole were interviewed by students at All Saints School in Manassas about their Vietnam War experiences. We met with the students separately at the Post Home on 5/3 and 5/6 for about an hour each. The questions were excellent, some I had never been asked before. And we even got some follow-up questions via e-mail.

Following the suggestion by Building Manager Wayne Moore, we will attempt to have some kind of showing of the winning Voice of Democracy and Patriot's Pen essays ready for our annual Post Picnic on June 2. We are trying to find an enclosed case or cabinet we can hang on the Post Home wall to permanently display the winning essays for visitors to read.

We continue to look for donations for the September 7 Youth Committee Yard Sale. Money from the Yard Sale goes to our essay contest prize fund. Call 703 220-4545 if you can donate something.

After much work and discussion on the Power Point presentation, the committee adjourned at 8:45 pm.

The next Youth Committee meeting will be at 7:00 pm Thursday, June 20 at the Post Home.

there was clear evidence that I had been wounded twice in my records, but no Agency would agree. Out of frustration, I wrote a two page letter to a very high ranking officer in the military to plead my case. Five days later I got a phone call from him and he said he would personally take care of the matter. Two weeks later I received the OLC for the Purple Heart. That renewed my faith in our military to do the right thing to remember service members after they have separated or retired.

So my message to other veterans is this: If you have a veteran issue, don't give up, don't stop trying, don't take 'no' for an answer and take the word 'can't' out of your vocabulary. If all else fails, talk to another veteran who just might have a solution. We're here to help.
