#### Recruiting '21 Dilemma

As we close out the 2020-2021 membership year and head to the Department Summer Conference June 3-6, our recruiting woes will be topic du jour. While Post 7589 is not alone in this plight, Covid 19 curtailed most activities for sound recruiting.

As the community opens, I urge a renewed effort and commitment to increasing our fold. The quartermaster has all the statistics on where we are versus where we should be. I chose not to lament the numbers we all know and the reason why.

However, I will share with you the Department's position and expectations on recruiting. While the information may be stale, it does indicate a need for a year-long full court press rather than a year-end scramble.

"Today we will drop below 800 on our way to 100%. We still need to average 22 a day to slide in under the deadline. This message goes out to over 400 members; if we all get 2 members between now and June 3rd, we can go to our State Convention as an All-American Department. It doesn't sound so difficult, does it. We have Memorial Day Weekend coming up, it should be a Poppy/Membership Drive weekend for every Post in the State. I encourage all Post Commanders to call any unpaid and see if the Covid virus has left them in financial difficulty; if so, use some Relief Fund money to help them out. Members of the State Team have worked with District 6 and District 2 the past 2 weekends. District 6 signed up 14 new, and 1 instate transfer, only 13 processed at National, District 2 worked the unpaid list and renewed or reinstated 13 members. Great work by both Districts, we should be doing something like this in every District every weekend until we reach our goal of 100%."



Tina Bliem reports that a total of 62 individuals participated in the event, to include eight VFW members and one VFW Auxiliary member, 28 Scouts, 15 Scout Leaders and 10 Quests. Six Scout Troops and three Cub Scout Packs were present. The Scout Troops were Troop 1372B, Troop 1372 G, Troop 30, Troop 670, Troop 1995 and Troop 2011. The Cub Scouts were from Pack 1372, 1355 and 1831. The weather was warm but clear and the event went smoothly without incident. Comrade Peter MacLeod took care of the Police Department authorization and I contacted and received permission from the City of Manassas Volunteer Fire Department. From all our estimates approximately 350 flags, or four barrels full were retired. We concluded the ceremony once all the flags were retired at about 11:00 and spent the last forty or so minutes cleaning up and closing down the event. I would like to give a big thank you to all those who participated, including the great members of the Youth Committee who make it happen, namely Alex and Tina Bliem, and Peter MacLeod.

The Civil Air Patrol, Prince William Composite Squadron from Manassas, Virginia recently held their annual award ceremony virtually and our Post was invited to attend. I presented two Cadet Awards that evening. The VFW NCO award went to CMSGT Vishvajit Senthilkumar and the Officer award was presented to C1st Lt Chris E. Pewett.

As far as JROTC programs we participate with and recognize, I am pleased to report that all three of our regular schools included us in their award ceremonies. Battlefield High School began the awards season for us. The Cadet recognized was Cadet Airman Shayne Cordell. His instructors said this first year cadet has a positive attitude and conduct. Unity Reed High School, formerly Stonewall Jackson, held their ceremony on 13 May. Cadet

Ashley Corrado Rivas won the VFW award for her program. She is currently a flight commander and Drill Team Leader. Osbourn Park High School was the most recent award ceremony held on 27 May with the award going to Cadet John Petro, a rising senior, who made a great contribution to the unit's Navy Nationals competition. All of these cadets received a VFW certificate, medal and ribbon from VFW Post 7589. All awards were presented at virtual ceremonies due to the pandemic.

During the Memorial Day weekend both the VFW and the Youth Committee will be extremely busy with Memorial Day activities. Scouts from Troop 1372, 670 and 30 and Cub Scouts from Packs 1355 and 1372 will be involved in flag placement for veterans at the city of Manassas cemetery on Monday, 31 May. In addition a wreath presentation and memorial service will be held at the gravesite of World War II Veteran PFC Francis H. Cannon who is our Post's namesake.

## City requests property easement donation for Quarry Road project

Dear Property Owner(s),

The City of Manassas ("CITY") is preparing for the upcoming construction of the above referenced project and has contracted with Rinker Design Associates, P.C., consultants for the CITY, to acquire the necessary easements. These easements will allow the CITY to provide streetscape improvements along Quarry Street as part of this locally administered project. Plans indicate that your property will be affected by these easements.

The enclosed plat identifies the easement required for this project. As shown on the plat, the easement is highlighted in the following color: Pink, showing the area of permanent utility easement.


Pursuant to Virginia Code Section 25.1-41 7(A) (I 0), you are entitled to be compensated by the CITY for this easement and are under no legal obligation to donate it to the CITY. The CITY is, however, requesting a donation of the easement since this project, when completed, may result in an improvement or benefit to your property. If you are willing to donate the easement without the payment of compensation, please complete the enclosed Donation Acknowledgment form.

The CITY is also required to make a determination of the value of the proposed easement and to provide you with a written copy of that determination. In addition to the requested donation of the easement, we are asking that you consider waiving the requirement for the City to prepare a valuation of the easement. You can indicate on the attached Acknowledgment form whether you waive the right to receive the City's written determination of value.

## 122nd VFW National Convention

\* If you made a hotel reservation at a hotel outside of the VFW room blocks (official VFW hotels: Hilton, Hyatt, Marriott, Sheraton, Renaissance) you will need to call the hotel you directly made the reservation with and cancel that reservation yourself.

## Blue Water Navy - Update

The Department of Veterans Affairs (VA) announced it will readjudicate claims for Veterans who served in the offshore waters of the Republic of Vietnam during the Vietnam War.

This review is part of the Veterans Benefits Administration's implementation of the November 5, 2020, U.S. District Court of the Northern District of California decision to re-adjudicate previously denied claims as applied in Nehmer vs. U.S. Department of Veterans Affairs.

Veterans who were previously denied service connection for an herbicide related presumptive condition due to lack of in-country Vietnam service will automatically have their claims readjudicated.

Re-adjudication means VA will review the evidence of record and provide replacement decisions in the cases of Veterans who were previously denied service connection for one or more herbicide related conditions on the basis that military service was not performed on the landmass of the Republic of Vietnam or on its inland waterways. This review will also apply to eligible survivors of deceased Vietnam era Veterans.VA is dedicated to ensuring all Veterans receive the benefits they have earned.

VA ensures that we have the proper resources in place to meet the needs of the Veteran community. Eligible survivors of deceased Veterans may also benefit from the policy and may be eligible for benefits based on the Veterans' service.

## VA national cemeteries no longer restricting gathering sizes at committal and memorial services

The U.S. Department of Veterans Affairs' (VA) National Cemetery Administration (NCA) today announced it would lift all restrictions on gathering sizes at committal and memorial services in VA national cemeteries starting on Wednesday, May 26, 2021. Earlier this week, the NCA announced it had adjusted its rules for visitors and staff members in accordance with the CDC's new guidance, Interim Public Health Recommendations for Fully Vaccinated People. Fully vaccinated persons are no longer required to wear masks and physically distance themselves while at a national cemetery.

Consistent with the new CDC guidance, NCA still requires persons who are not fully vaccinated to practice the safety procedures recommended by the CDC – such as wearing face coverings and maintaining physical distancing – while visiting a cemetery or attending a service.

## SGT Nicholas C. Mason VFW Post 12202 opens in King George

On a sunny Saturday afternoon that also marked the first day of May, 33 veterans raised their right hand and became chartering members of the VFW Virginia's newest Post, the SGT Nicholas C. Mason Memorial VFW Post 12202 in King George County. With Past State Commander Ken Wiseman as the Master of Ceremonies and State Commander Eric Mallett serving as the installing officer, it was a day few will forget.

Commemorating the memory and legacy of beloved native Nick Mason, who was killed in Iraq in 2004 while serving with C Company, 276th Engineering Battalion, Virginia Army National Guard, elected officials and members of the community joined the VFW in opening the Post with pomp fitting for such an occasion. SGT Mason's parents and sister were the distinguished guests for the event that saw nearly 100 people assemble at King George High School where Nick had been a star athlete.

Past State Commander Wiseman gave the keynote address and encouraged the members of the Post to hold their officers to the same standards that Nick Mason lived his life and to take the opening of the Post as "a blank canvas allowing you to do so many things".

State Commander Mallett noted that there has not been such a large group installed nor has Virginia ever seen a Post come together this fast. "It is amazing what you were able to do with social media and local connections to overcome the COVID pandemic and deliver a new Post" Mallett said.

SGT Mason's mom presented the Post with American flags that had been flown over her son's grave earlier that morning. Nick's mom and dad both commented on how proud they were to see another effort to commemorate their son. They ended their comments by saying they looked forward to becoming members of the Auxiliary which will soon open and be part of the Post.

Also in attendance was Nick's then-platoon leader, Beau Mason, who is now a Lieutenant Colonel in the Virginia Army National Guard. "Nick was the kind of soldier everyone could respect for his service but also the one who was just fun to be around, which is to say he also was a joker" LTC Mason said, causing the crowd to laugh. He added "I have spent hours with Nick's family trading stories about the things he did and I look forward to being a member of a Post named after Nick."

While the Post is only just starting, the fact was clear that this Post will fit very well within the King George County community and the VFW as a whole. With the namesake of SGT Nicholas C, Mason, the beloved local boy who served with honor, there is only positivity that lies ahead for them.

## Veteran of three US wars surprised with a boat trip on his 100th birthday

ARLINGTON, Va. (7News) — [April 20] It was just before 10 a.m. at Pohick Bay Regional Park in Fairfax County and nearly 100 people were gathered. Members of a veterans motorcycle club, local firefighters and first responders, and even a Color Guard from the neighboring VFW [and American Legion].

All were waiting for the arrival of Ed Ettner, a veteran of three wars, on his 100th birthday. Finally, he pulled up with a police escort to a round of applause. The crowd sang him happy birthday.

"It's unbelievable, big surprise," he said with a huge smile on his face. "It's hard for me to soak it in. Feel good? Yeah, damn it."

Then, another surprise. He was loaded on a custom-made boat by the organization Veterans Fishing Adventure, for a day on the lake. Not his first time on a boat. Ettner served in the Navy during World War II, Korea and Vietnam. Most of his time was actually spent below the surface, though, as a submarine commander.

He spent the afternoon smiling and saluting those around him.

"It's hard to describe in words when people take the time and effort to come out and honor you, it's awesome," he said.

All of this was put together by Ed Moore, founder of the Veteran's Fishing Adventure program, which takes veterans fishing to help heal their invisible wounds from war.

"It's memories for a lifetime, however long that lifetime is," Moore said.

As they rounded the lake, Ettner was all smiles, enjoying being out on the water. He recounted some of the missions he was a part of during the three wars he fought in, talked about his late wife and children, and the life he's had.

As the trip was wrapping up, Ettner said he wanted to be remembered as someone who "lived a good life, married a good woman, had good children, and did the job."

"Whatever job they gave me I did it to the best of my ability," he said, "and I think I did a lot of good for the country."

## Who invented charcoal briquettes?

On June 16, 1903, the Ford Motor Company was established. Henry Ford was the founder. This was not his first rodeo, as he had previously operated the Henry Ford Company. He left that company and took his name with him. What became of the Henry Ford Company? They became known as the Cadillac Motor Company.

What does any of this have to do with a BBQ grill? Hang on.

Ford's Model T, which would number in the millions sold, required 100 board feet of wood to build. Ford despised waste. His motto was, "Reduce, reuse, and recycle." He was also a naturelover, an environmentalist of his time. His escape from the stress of life was camping in the great outdoors.

Frustrated by the mountains of sawdust his lumber mills created, he and his partners sought a way to utilize the scrap wood and sawdust into a useful (and profitable) product.

An idea came to him one day as he was camped with some friends in the wilds of Michigan . After his party spent a long time collecting sufficient wood for a campfire, an idea sprung in Ford's mind. Upon returning back to the lumber mill, he shared the idea with some of his partners and set to work on it.

The idea? Lumping a fistful of sawdust and cornstarch with a bit of tar to form a briquette. After charring it, it performed exactly what Ford imagined it would. He then built a charcoal briquette factory adjacent to his lumber mill where the waste from one became the fuel for the other.

A new Model T was now frequently sold with a bonus bag of Ford Charcoal Briquettes, so you could drive into the woods to meeting. 


