New VFW Auxiliary Now Welcomes Men

Historic change reflects today's military and veteran families

KANSAS CITY, Mo. (August 21, 2015) — [August 21], John A. Biedrzycki Jr., national commander of the Veterans of Foreign Wars of the United States (VFW) added his official signature to the new congressional charter of its Auxiliary organization in a historical event solidifying the VFW's commitment to membership equality for all military families.

The former Ladies Auxiliary VFW, founded in 1914, is the VFW's highly regarded support organization and is considered its "Partner in Service."

Under its former name Ladies Auxiliary VFW, membership within the organization was offered exclusively to female spouses and family members of any member of the Veterans of Foreign Wars. The gender-specific eligibility requirement remained for more than 100 years until July 20, 2015, when delegates to the VFW's 116th National Convention in Pittsburgh voted to

amend the dated by-law to extend the same membership opportunity to eligible males.


Appropriately, the Ladies Auxiliary VFW has changed its official name to the VFW Auxiliary.

"It's an exciting time to be a member of the Auxiliary," said National President Francisca Guilford. "Women comprise nearly twenty percent of our nation's military, and this change allows all spouses, fathers, grandfathers, sons, grandsons and brothers to serve others in honor of their veteran."

Currently, the Auxiliary has more than 465,000 members, a number that is now expected to sharply increase over the next year. Its members represent all 50 states, the District of Columbia, several foreign locations including Germany, Guam and Panama, and have made an impact in local communities around the globe.

Last year alone, its members worked to provide \$4.6 million dollars in monetary aid to veterans, active duty military and their families, and volunteered nearly 800,000 hours in VA Medical Centers, hospitals, nursing and veterans' homes. Auxiliary members also contributed greatly to cancer research, youth activities, civic patriotism and much more.

Post Commander's Report

When I was about three years old, many years ago, we had a young paperboy in our neighborhood who delivered the afternoon newspapers to our house every day. He was in high school and came by on his bike and if I was outside playing, he would roll a ball over to me or help me line up my toy cars and trucks. I got in the habit of waiting for him every day. All of a sudden, he didn't come by any more, there was a new kid delivering the papers. My mother said something about the Kinder boy had enlisted in the

Marines and was on his way to Korea where a war was raging. Soon the family learned he had arrived just in time to be in the intense fighting around the Chosin Reservoir when the Chinese entered the war. He was listed as "Missing in Action." And he still is today. In front of City Hall in Marlborough, Mass. his name stands out in bold letters as one of the Marlborough "boys" who didn't make it home from the Korean War.

Unfortunately this story is not that rare or unusual in our country. The Defense POW/MIA Accounting Agency, as of August 26, 2015, still lists 7,841 U.S. service members as missing from the Korean War. There are still 73,515 missing from World War Two. 1,627 missing from the Vietnam War and 132 missing from the Cold War, Desert Storm and the Iraq and Afghan wars.

It is especially excruciating for the families of these missing people. There is no closure. In many cases, no funeral or gravesite where relatives and friends can pay their respects. I know the parents of my missing paperboy had a very hard time dealing with it and the family eventually moved from town. That is why the gloomy task of finding the remains of missing military mem-

bers is so important. Closure is so important to the families and friends of the missing in action.

Our own Post 7589 member and former commander Jerry Martin and our Service Officer Steve Botello are involved with the Kuentai-USA group of Japanese and Americans which is working hard recovering Japanese and American M.I.A.'s in the Pacific islands where so many battles were fought during World War Two. And if you subscribe to the weekly online news report put out by the VFW Action Corps Weekly you can keep up on the latest worldwide recovery efforts.

In fact in a recent Action Corps dispatch there was news about the recovery of remains belonging to U.S. Army Sgt. Christopher V. Vars of Amherst, N.H. who died fighting with the Army's 2nd Infantry Division around Chosin Reservoir in North Korea on Nov. 29, 1950. The Action Corps Weekly allows you to click on a link and find the details of what happened to Sgt. Vars.

Mary McClung, daughter of a missing Marine from Korea, said she was only three years old when her father was lost. But this summer she attended a conference put on by the Defense POW/MIA Accounting Agency (DPAA) in Washington. As families told stories of their lost loved ones she told the DPAA she felt a common bond with the people she met and talked to at the conference. And even though her dad has been missing for over 60 years she said she is still curious about what happened to him and is glad there are agencies and groups who are out there still looking and searching.

And of course there are the former POWs. Merle Hancock of our Post 7589 has a riveting story of capture by the Germans during World War Two.

That is why I urge you to take time during National POW/MIA Recognition Day on Sept. 18 to attend ceremonies and services and remember the missing and the POWs from our wars and support efforts to make sure they all come home!

Notes from the trenches

"In my monthly words I want to make sure I have a balance between Positive and Negative matters. This is all positive.

First, In a recent article for Post Newsletter I lamented the fact that an innocent individual was murdered on a Metro train with many on-lookers doing nothing to stop the outrage. Just this last week two American servicemen on a train headed for Paris took decisive action to prevent the murder of scores of innocent people. It was a classic case where the courage and initiative of a few spurred others into action. Over and above saving the lives of fellow passengers the two servicemen reflected great credit on all Americans in uniform before the international press.

The second bit of good news concerns the upcoming establishment of a "Veterans Treatment Court" for Fairfax County. This



is from an initiative made by Judge Penny Azcarate (Chief Judge of Fairfax General District Court). Judge Azcarate is a USMC Veteran of the Persian Gulf War. As a veteran she was appalled by the numbers of veterans who repeatedly appeared before her court with obvious service related issues. Research shows one in six service members who served in Operation Enduring Freedom or Operation Iraqi Freedom have substance abuse problems. Research shows there is a link between combat stress and substance abuse. Vir-

ginia has the sixth largest population of veterans in the Nation (850,000). Fairfax alone has 85,000. Establishing a Veterans Treatment Court is a serious undertaking. It will entail coordinating multiple local and federal agencies and specific training to ensure a smooth start. Veterans will be assigned mentors, receive close follow-up, random and frequent drug testing and employment assistance. Funding will come from the Department of Veterans Affairs. Current plans call for the operation to begin in January 2016. We will be closely following the progress of this badly needed initiative.

The third bit of good news concerns the Post Aluminum Can Tab

collection program. We established a goal of 200,000 tabs for 2015 and we now have 219,000. We have 34 collection containers distributed throughout Manassas, Gainesville, Warrenton and Haymarket with more to come. This is more than about raising money for the Boston Burn Center. The program goes a long way to show the public how the VFW is active in their community. When Joel and I distribute and collect the full containers we make a point of going with our VFW shirts and caps which results in "High-Fives" salutes, and pats on the back. Makes it all worthwhile. A lot of credit needs to be spread around but I want to specifically mention Rick Raskin, Pete Slusher, my brother Joel and the Inter-Service Club Council (ISCC). We have already started sending VFW letters of appreciation and thanks signed by Post Commander Peter McLeod to the standout establishments who have given the program exceptional support. When I've gone to the places who have received our letters of appreciation they seem a little overwhelmed that we would go to such lengths to thank them.

It is heartening when there is positive news about Americans in uniform and how the community is assisting in helping those in need and there is action being taken to solve the special needs of veterans. It does not get much better than that.

Wallet Left Behind 70 Years Ago in Austria During World War II Returned to California Veteran

A wallet lost 70 years ago by an American soldier in Austria during World War II was returned to its rightful owner thanks to a doctor who discovered the item in his late grandfather's farmhouse.

Josef Ruckhofer told AFP he had been renovating the house near the city of Salzburg when he stumbled across the leather wallet under a wooden plank in June.

Military identity papers revealed that the purse had belonged to Eligio Ramos, an American soldier from Texas whose battalion had been stationed in Austria in 1945.

The wallet also contained "family photos of a woman and child and old stamps, but no money", Ruckhofer said.

"Given that we've been commemorating the 70th anniversary of WWII this year, I thought it would be a nice idea to find the owner and maybe return his wallet, if he was still alive," he added.

After an online check of Texas phone directories failed to turn up results, Ruckhofer expanded his search to the whole of the United States.

He eventually found a man in California whose name and birth-date matched those of the soldier.

"I sent a letter with a copy of the identity papers and a few of the photographs to that address, asking him to get in touch if he was the owner," the Austrian explained.

"After a week or so, I received an email from his son confirming that I'd found the right Eligio Ramos. He said he would be very happy if I could send him the wallet."

Ruckhofer learnt that Ramos had lost his wallet when he and his battalion spent a night at the Austrian farmhouse.

The doctor said he had not been able yet to speak to the American because he was in hospital.

"As it turns out, he is the only survivor of his battalion," Ruckhofer said. "Maybe we'll still find a way of talking directly to each other. —From AFP

Wills for Veterans

An Important Scam Notification from USAA

Social media scam targeting service members

DO NOT provide your personal banking information through social media.

There is a social media scam, predominately seen in Instagram, which is targeting military service members. This scam has been around for over a year, but has picked up steam over the past few months and more and more people in and out of the military are falling prey to fraudsters. Please review the following items and stay alert.

The fraudsters are targeting military, veterans and their families. In exchange for their personal banking information, they are promised the ability to make easy money. The victim provides their log in/password information and the fraudster gains the ability to deposit fraudulent funds directly into their account. They immediately pull out their fee, before the institution can identify the credibility of the deposit, and the victim is left responsible for the used funds. The amounts range from \$2K to \$20K, growing the debt of the victims in a matter of minutes.

The consequences are very unpleasant - you are responsible to pay back the entire amount. Funds are transferred to collections, impacting the victim's credit score and could even result in criminal charges.

Take a moment and think about offers that seem too good to be true. If you have to question if it is legit, walk away. Many victims thought the most they could lose was the balance in their

account – they were wrong.

To the people who influence the potential victims, take time to be an advocate and help us educate. They are being taken advantage of and it is our obligation to protect them.

Here are some tips. Make sure to read, follow and share, regardless of where you bank:

- Offers of free money. USAA (and no other legitimate financial institution) is NOT going to post offers of easy money on social media.
- Odd phone numbers. A credible USAA number is either a 210 area code or 800 number.
- Requests for your information. Fraudsters ask for things

USAA or any other legitimate institution would never ask for, such as personal identifiers, debit card information and account numbers — USAA and legitimate banks already have all that.

- Unprofessional pictures. The pictures (fraudsters use) on Instagram might show cash or risqué images of women. They are not images representative of legitimate bankers, investors or USAA employees. That's not USAA's image.
- Directions to send money back. USAA recently had a conversation with a fraudster posing as a USAA official. The scam was an offer to deposit unclaimed insurance money into the member's account but required a 50% fee to be sent back to the fraudster after the deposit was made. USAA or any other legitimate financial institution would not deposit funds into a member's account and ask them to send half back.

Another PC Scam—Beware

Several of our members have recently reported a phishing scam making the rounds. An email claims that your PC is infected with numerous errors and that you should click on an enclosed link to initiate repair. BEWARE! This is a scam and the sender will install malware on your machine, take control and then charge you to remove it.

DO NOT CLICK ON ANY LINK OR DOWNLOAD ANY PICTURES UNLESS YOU ARE ABSOLUTELY SURE THAT THEY ARE GENUINE.

Check the sender's address and even if it is someone you know, be wary. As shown below, the senders address is in India. Ask yourself, "How in the world would they know that my PC had errors?"



This is a dead give-away. The domain suffix is .in = India

Also, there is another scam where you receive a phone call basically telling you the same thing. The caller asks for access to your machine to clean up errors after offering you a tech support agreement.

DO NOT FALL FOR THIS ONE EITHER!

Again, how in the world would they know your PC had errors?



DOD Announces New Prescription Drug Policy:

This week, the VFW was briefed on the new TRICARE policy that will require military retirees and family members to obtain certain prescription drugs through the mail or at a military treatment facility (MTF). The change affects only maintenance medications. Acute medications such as antibiotics may still be obtained through retail pharmacies. Active duty military are exempt. Similar to the TRICARE for Life pharmacy mail order pilot program, generic formulary drugs will be free with home delivery and name brand formulary drugs will cost \$16 for a 90 day supply. This is compared to \$8 for generics and \$20 for name brands currently charged at network pharmacies for a 30 day supply. There is no charge for drugs obtained at MTFs. DOD estimates this new policy will save \$88 million a year for them, and \$16.5 million a year for beneficiaries. Receiving a single name brand drug through home delivery rather than a retail pharmacy will save beneficiaries up to \$176 per year. Affected beneficiaries will begin receiving letters on September 1 with additional information on the new policy and how to obtain waivers if necessary. DOD Launches Website on New Prescription Drug Policy:

Earlier this month, the VFW reported on a new TRICARE prescription drug policy that will require certain beneficiaries to refill select maintenance medications through home delivery or at military treatment facilities. This week, TRICARE published a summary of the changes on its website, including which beneficiaries will be affected, which medications will fall under the new rules, how to request waivers if necessary, and contact information for additional questions. Active duty military personnel are exempt from the new policy. The change will take place on October 1, 2015, and DOD will begin sending letters with additional information to beneficiaries on September 1. VFW's Motion Granted: Unseal Prudential's SGLI Records

All documents had remained sealed at Prudential's request

KANSAS CITY, Mo. (August 26, 2015) – Yesterday, U.S. District Judge Michael A. Ponsor issued a ruling that grants a motion filed by the Veterans of Foreign Wars of the United States (VFW) to unseal documents related to the class action lawsuit brought against the Prudential Insurance Company of America, subject to certain exceptions. The suit was filed in response to the company's administration of the Servicemembers Group Life Insurance (SGLI) program for the Department of Veterans Affairs.

The underlying case alleged that Prudential failed to pay death benefits to military service members, veterans and their families in the manner required by the laws governing SGLI and the Veterans Group Life Insurance (VGLI) programs. That lawsuit was resolved in December 2014 in a nearly \$40 million settlement.

"We're pleased with Judge Ponsor's ruling and now have a lot of work to do. We anxiously await the opportunity to re-

view the documents involving this matter," said John A. Biedrzycki Jr., VFW national commander. "We want to better understand the manner in which Prudential and the VA have been administering these programs. And through this review, we will continue to be the voice for America's combat veterans and their families."

Filing the motion in June 2013, the VFW has consistently taken the position that documents filed by Prudential should be made available to the public. Yesterday's ruling requires Prudential to disclose all but 16 of the documents it has been arguing should remain from public view. The parties must file all other documents (not redacted) by September 28, 2015, according to the ruling.

Prudential has denied wrongdoing throughout the proceedings, but most of the records filed in the case have been sealed from the public at Prudential's request. The VFW insists that it is in the best interests of the families and the public to fully understand what Prudential has done in connection with its administration of federally subsidized life insurance programs for service members and veterans. Yesterday's decision underscores that.

NPRC 1973 Records Fire

► What you Can Do To Help Recover Data

Shortly after midnight, on July 12, 1973, a fire was reported at the NPRC's military personnel records building at 9700 Page Boulevard in St. Louis, MO. Firefighters arrived on the scene only 4 minutes and 20 seconds after the first alarm sounded and entered the building. WWI, WWII, and Korean War Veterans' files were stored in cardboard boxes stacked on steel shelves lining the sixth and top floor of a large, rectangular federal building. They were packed so tightly within the thousands of boxes that, when the fire erupted, it burned so intense, so quickly, so out of control, it took the responding 43 fire departments more than two days to smother. During the long ordeal, firefighters faced severe problems due to insufficient wa-

This has proved helpful and hopeful for the many "treasure hunt" stories that occasionally surface in media profiles. But, what about those whose records were not recovered?

ter pressure. Exacerbating the situation, one of the department's pumper trucks broke down after 40 hours of continuous operation. Numerous times, the fire threatened to spread down to the other floors; but firefighters were successful in halting its advance.

When the smoke settled and the interior temperature cooled, the building's staff found that up to 18 million Veterans' personnel records had been reduced to smoldering piles and puddles of ash. While millions of records were destroyed, some survived but remain badly damaged. There was no motive, no suspect, and few clues. The person(s) responsible for destroying 80 percent of Army personnel records for soldiers discharged between 1 Nov 1912 to 1 Jan 1960 and 75 percent of the Air Force records of Airmen discharged between 25 Sep 1947 to 1 Jan 1964 (with surnames beginning with Hubbard and running through the end of the alphabet) has never been found.

There is a specific request form at www.archives.gov/st-louis/military-personnel/na-13055-info-2-reconstruct-medical-data.pdf which you must fill out that gives VA the authority to ask NPRC to reconstruct that file. This request provides information that allows the NPRC to search for other types of documents, such as individual state records, Multiple Name Pay Vouchers from the Adjutant General's Office, Selective Service System registration records, pay records from the Government Accounting Office, as well as medical records from military hospitals (current Army list; current Air Force list), unit records and morning reports, and entrance and separation x-rays and organizational records, that would assist you with your VA healthcare access or compensation claim, or for valuable research on your family member's service history.

When it comes to VA compensation, however, maybe you don't have time to play detective. It is critical, in the request you send to VA, that you provide as much information as you can, includ

ing the units you were assigned to, as well as the name of the company, battalion, regiment, squadron, group, and/or wing. VA will accept, as alternate sources for records, statements from service medical personnel, certified “buddy” statements or affidavits, accident and police reports, Employment-related examination reports, letters written during service, photographs taken during service, pharmacy prescription records, insurance-related examination reports, medical evidence from civilian/private hospitals, clinics, and physicians that treated you during service or shortly after separation, and photocopies of any service treatment records that you may have in your possession.

It is important to note that, although these details can significantly help, VA does not rely only on service treatment records when deciding claims for cases that are related to the 1973 fire.

While this can appear daunting, there is help available; VA encourages you to work with an accredited representative or agent if you need assistance. Go to <http://www.va.gov/ogc/apps/accreditation/index.asp> to verify accreditation. You can also request an attorney, claims agent, or Veteran Service Organization representative online.

The ramifications of this tragedy have been longstanding and well documented, and it couldn’t have happened to a more heroic group of Veterans at a worse time—when those files were needed most. Archaeologists two centuries from now are not going to magically dig up microfiche duplicates that were never created. Those records are lost to time. With NPRC’s assistance, VA is committed to ensuring that no eligible but affected Veteran goes without the benefits and services (or information) to which he and she have earned. In 2012, NPRC relocated to a new building housing 60 million records (from the Spanish-American War to about the year 2000) in 1.8 million boxes “in a climate-controlled warehouse with a constant temperature of about 35 degrees and with a relative humidity that never dips below 40 percent.”
