## GREETINGS FROM THE COMMANDER

First off, I would like to thank the membership for your vote of confidence in me by re-electing me as your Post Commander. The new year of service started at the State Convention in Richmond after the new State Commander, Hal Roesch and the rest of the new state officers were sworn in.

I am pleased to report that our Post was awarded All State status while we were at the convention. I proudly accepted the banner which is now displayed on the wall at the Post. Only 20 Posts out of 169 are awarded All-State status. It is through the efforts of the members of the Post doing the business of the VFW which enabled us to achieve this recognition. We've had a very productive year in service to veterans, community, and youth.

This past month, we've joined with the Virginia Department of Veterans Services of the Commonwealth of Virginia in providing one of their Veterans Claim Agents, space within the Post for the purpose of assisting ANY veteran, or spouse of a deceased veteran with claims with the Department of Veterans Affairs. Whether assisting with the establishment new claims, existing claims, or assisting surviving spouses of deceased veterans who had been receiving compensation with obtaining their rightful surviving spousal benefits, they are here every first and third Tuesday of the month between 9:00 am to 3:00 pm. No appointment necessary.

We are in the process of adopting the 266th Military Police Company (National Guard) based out of the Manassas National Guard Armory. We will be planning activities to encourage morale to those who are deployed and for their families here at home. Anyone with ideas on how we can assist them, please come to a meeting and make your proposal!

If you know someone who's eligible to join our Post as a member of the VFW, ask them to consider joining the largest and in my opinion, the best combat veterans organization in existence. The Veterans of Foreign Wars is you. There is no VFW without members. Help us continue to help those of us who may still be serving in harm's way, who may be recovering from wounds suffered while in defense of our nation. For those of us who are Vietnam vets, we remember how we were received when "we came back to the world". Many of us have promised that that kind of treatment will never happen again. Many younger veterans have families, jobs, and other important aspects of life that have a higher priority than belonging to a service organization that would divert time and energy away from their loved ones. But have them consider their comrades who didn't make it home or sustained serious and life changing wounds. What about them or their loved ones. What needs do they or their families have that can't be met without assistance. Who will help? Each of us giving a little bit of time can make a huge difference in the lives of our fellow comrades and their families. We need more members to continue to do the business of the VFW. Help us do that. It's not difficult. On July 5th, Senior Vice-Commander Pete MacLeod, Quartermaster Rick Raskin, Adjutant Mike Guttman, Post member Ramon Feliciano, and myself manned a booth at the "Car Show for the Troops" held at Old Dominion Speedway. All proceeds from this event went to support the Fisher House in DC. Each of us who participated had a good time while there, and we were able to recruit 11 new members to the Post. It is not difficult to recruit a new member if you speak from your heart.

**National Defense Authorization Act for FY 2008 (Public Law 110-181)**

The following was announced at the State Convention held in Richmond last month.

The National Defense Authorization Act for FY 2008 (Public Law 110-181) signed by the president on January 28, 2008 includes Section 294 "CONDUCT BY MEMBERS OF THE ARMED FORCES AND VETERANS OUT OF UNIFORM DURING HOISTING, LOWERING, OR PASSING OF UNITED STATES FLAG". According to the law, "all persons present in uniform should render the military salute. Members of the Armed Forces and veterans who are present but not in uniform may render the military salute. All other persons present should face the flag and stand at attention with their right hand over the heart, or if applicable, remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart. Citizens of other countries present should stand at attention. All such conduct toward the flag in a moving column should be rendered at the moment the flag passes."

The Virginia Department of Veterans Services of the Commonwealth of Virginia and VFW Post 7589 have joined into an agreement for our Post to provide space every first and third Tuesday of every month to Veterans Claim Agent Mr. Angel Lugo.

The purpose of this agreement is to assist ANY veteran, or spouse of a deceased veteran with claims with the Department of Veterans Affairs. Whether assisting with the establishment new claims, existing claims, or assisting surviving spouses of deceased veterans who had been receiving compensation with obtaining their rightful surviving spousal benefits, Mr. Lugo is here every first and third Tuesday of the month between 9:00 am to 3:00 pm. No appointment necessary. This will save you from having to travel long distances to try and work your claims. With the price of gas and diesel these days, not only will it save you time but significant money.

For those of you who are Vietnam vets who have Diabetes Type II, you are presumed to have come into contact with Agent Orange and you are eligible for compensation from the Department of Veterans Affairs. I know this for a fact because I've gone through the application process and in my particular case, I've been awarded a 40% compensation. This money is tax free. You were exposed to Agent Orange, you should get the compensation due you!

The members of Congress have a vested interest in protecting their ability to be re-elected. Believe it or not, your membership in organizations like the VFW do protect veterans rights.

### VFW and American Legion Donations Enable Wounded Vet to Obtain Racing Bike

Jonathan Pruziner was a member of 3<sup>rd</sup> Striker Brigade when he was hit with an IED on September 11, 2007. He was 21 years old and had been in country for less than two months. His wounds led to the loss of his left leg below the knee, and his long term treatment and rehabilitation has been at Walter Reed.

Jon has long held a goal to be a competitive cyclist, and with his new prosthetic he revived this dream as part of his rehabilitation plans. His Army pay just didn't give him the means to purchase a bike that would meet his demands.

VFW Post 7589 in Manassas provided the first donation to this cause, with American Legion Post 10 adding to it and handling the banking. Additional donations were made by AL Posts 364 in Woodbridge, 247 in Remington, and 1711 of Levittown, NY, where Jon's grandfather is a member. In addition Walter Wood of Woodbridge, Paul Brown of Bealeton, and Theresa and Tom Wahl of Manassas made individual contributions.

On May 29, Jon and his girlfriend Erica drove from the Walter Reed Fisher House to Manassas to visit A-1 Cycling. Manager Ben Williams took the time to fit Jon to a full carbon fiber bike as well as helmet, shoes, and some other essential accessories. Jon's prostetist has since fit him with a lower section especially made for riding.

Jonathan has been welcomed as a new member of VFW Post 7589 and American Legion Post 10, both in Manassas. He has decided that the Capital Area is pretty friendly, and is working on a permanent transfer to the area.

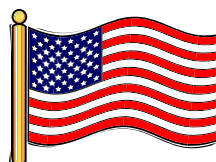
