Commander's Message

Comrades,

Over the past 3 months, I have received numerous messages from Department Commander Ken Wiseman. I find it only fair to share with you some of the things he has on his plate but only imparts to his Post Commanders. He intends for Post Commanders to disseminate these things to their Posts. The few notes below are important on a local and national level to

VFW members.

Disaster Relief Donations

On behalf of the Commander-in-Chief, thank you for your out-pouring of prayers and donations for those who experienced the path of the many natural disasters last year, and those so far this year. As a result of the many recent disasters, we now, unfortunately, have an extremely low balance in our Emergency Relief Fund. So, I am asking for your help again this year to supplement our funds so that we will be able to offer support to areas that could be impacted this year.

The VFW's Emergency Relief Fund established several years ago, provides us with a broader relief opportunity and allows us to provide immediate relief to those states and territories affected. Departments, Districts and Posts wishing to contribute to the VFW relief efforts needed for those in the path of natural disasters are encouraged to donate to the VFW Emergency Relief Fund.

Some have asked if Post Relief Funds can be used to assist with donations. The answer is YES.

NDAA Conference Report Includes VFW Priorities

Yesterday, the House passed the negotiated conference report for the John S. McCain National Defense Authorization Act (NDAA) for Fiscal Year 2019. The VFW thanks the conferees and the more than 7,000 veterans and supporters who responded to the Action Corps Action Alert opposing a provision that would have dramatically increased TRICARE fees for current retirees. The final bill does not include the misguided proposal. The final bill does include several provisions to improve the financial viability of the Armed Forces Retirement Home, such as authorizing the home to accept financial gifts and expanding eligibility to disabled veterans and spouses who are not currently eligible. The bill would postpone the fee increase that was scheduled to be implemented in October 2018 but applies only to those who were residents as of April 9, 2018, and authorizes gradual fee increases over the next three years. The bill would also authorize a 2.6 percent pay increase for America's service members; grant disabled veterans access to commissaries and Morale, Welfare, and Recreation facilities; require DOD to design and produce a medal or award for veterans exposed to radiation (Atomic Veterans); improve reporting, investigation and prosecution of sexual assault cases; expand eligibility for Military OneSource to one year after discharge; and require DOD to conduct an assessment on ways to enhance and reform Taiwan's military forces. The Senate is expected to consider and pass this important bill before departing for its August state work period

VFW Urges MIA Families to Provide DNA Samples

"Some 5,300 of 7,699 American unaccounted-for war dead are believed to be in North Korea, and 111 of our 126 Cold War missing are in the vicinity of the Korean peninsula, yet family reference samples on file only account for 91 percent of Korean War missing and 85 percent of Cold War losses," said new VFW National Commander Vincent "B.J." Lawrence.

"We have to do better than that, and that's why I'm calling on more than 1.6 million VFW and VFW Auxiliary members to canvas their neighborhoods and urge every MIA family — even distant relatives — to provide a family reference sample in the hope that the next identification announcement is their long-lost soldier, sailor, airman, Marine or contract civilian."

As you might remember, due to a Pentagon computer system glitch, over 133,000 combat-wounded veterans had their disability severance pay improperly taxed. Those veterans will soon get a refund, thanks to legislation I co-authored with Senator John Boozman, a conservative Republican from Arkansas. So today I'm writing to let you know the Pentagon and the IRS have officially sent out instructions for veterans to apply for those refunds.

Those instructions are available <u>here</u>. If you are a veteran and think you may have had your severance pay improperly taxed, I encourage you to read the instructions, and if you need help, to contact my Roanoke Office: (540) 857-2676

Post approves pursuing merger with Manassas Park Post 1811

Monti Zimmerman, Commander of Post 1811, Bill Sly, Quartermaster and Scouting Chair Alex Bliem attended our September membership meeting and explained the rationale Post 1811 is requesting to consolidate with Post 7589. They explained that their Post is at the point where they will not be able to seat a slate of officers for the forthcoming year and that they only have a few thousand dollars in funds. Since they sponsor a Scout Troop they are concerned that in addition to their Post running out of funds and not being able to continue their Scouting activities, they will be closed for lack of a slate of officers. Post 1811 voted to pursue the merger.

After considerable discussion we determined that our Post could pick up the Scouts and Alex Bliem would continue to head that committee. Additionally, Post 1811 committed to have enough funds available for two years of Scouting sponsorship (currently \$1000 per year).

Post 7589 then voted to pursue the merger.

In order to proceed with the process of merging a committee consisting of members from both Posts will be formed to work out the details. Post 7589 Senior Vice Commander Ron Link agreed to head that committee.

Following the committee's report, the clock starts on completing the process. Due notice will be given inviting members of both Posts to attend a special meeting and vote on the proposed merger. This meeting will be chaired by a Department Line Officer. If the merger is approved, it will take approximately 3-4 weeks to complete.

Post 7589 would gain about 50 members, the majority of whom are life members.

Medicare Verified: FRAUDULENT PHONE CALL

The following was reported by one of our members:

To anyone who is on Medicare, I want to alert you to a FRAUD.

I got a phone call today from a man who said his name was Kelly and that he was a supervisor calling from Medicare. He asked me if I got my new Medicare card. He verified my name and address (I did not give it, he already had it). He said that he needed to activate my card so I would get continuous coverage.

He asked for my NEW Medicare number on my card.

I refused to give it to him and he got very insistent and said if I did not give it to him, he could not activate my card and I would not have coverage.

He asked if I got a letter and I said I did, I got it out and looked at it and it did not say someone would call to activate coverage. I told him this and told him that I would call the phone number on the back of my card as I was not sure this call was legit. He insisted that it was and that he would be the person I would talk to if I called Medicare. He even verified the same phone number that is on the back of my card.

I hung up to his protests that I would no longer have coverage.


I called Medicare and they verified this phone call was a FRAUD from someone trying to get personal information.

Medicare said they would NEVER call to activate a Medicare card, it isn't required.

Medicare said they had other reports of this type of scam and encouraged me to spread the word for others who got calls like this to NOT give out any information.

I can see how others may not be suspicious like me and get talked into giving out their Medicare number and other information. This man was very insistent.

The new look will be spearheaded by the deployment of a new, modern and simplified VFW logo designed to better convey who we are as an organization, and allow us to stand out in an increasingly competitive media market. In short, this new logo will strengthen the VFW brand, reaffirming our position as America's greatest veterans service organization and allow us to better connect with new audiences. For clarification, the Cross of Malta will always remain the official seal of the VFW. We are not leaving the Cross behind, but rather elevating the importance of the Cross by limiting its usage to instances in which it can be fully reproduced, and instances which require formal representation of our brand. The Cross represents the highest ideals of the organization and should be afforded a degree of reverence when it is displayed.

In an effort to make this transition as seamless as possible for you to implement, we have taken great care to develop:

- 1. A download package which includes all approved versions of the VFW logo in various file formats.
- Download the VFW logo package at: https://vfw.sharefile.com/d-sa998388928144509
- 2. A comprehensive style guide detailing proper logo usage. (Attached.) Please review the style guide completely and thoroughly.
- 3. A custom logo for each Department and Post using a standardized format. Please adopt and utilize these logos to identify your Department or Post as appropriate.
- See Section 3 of the style guide for instructions on down-loading your custom logo.

We understand many of you have expended resources over the years to obtain merchandise and material displaying the current VFW logo. We are sensitive to this, and therefore, it is acceptable should you choose to exhaust your current inventory of VFW-branded print materials and continue to use VFW-branded merchandise until it is time to reorder or until the year January 1, 2021.

Please note:

- 1. All future orders of VFW-branded collateral will display the new logo. The VFW Store will begin expanding merchandise offerings which display the new logo while limiting options displaying the Cross of Malta, however, all offerings in this year's Store catalog which display the Cross will be honored.
- 2. For those of you using the Website Solution Program platform, the logo update will occur automatically on November 6.

Exciting times are ahead for our great organization, and we truly appreciate your every effort to implement the new logo on, but not before November 6.

VFW Fall Legislative Conference:

VFW National Legislative Committee members from nearly every state traveled to Washington to meet with their members of Congress and advance the VFW's 2018 Legislative Priority Goals. Committee members asked their Senators to swiftly pass H.R. 299, which would provide long overdue benefits for Blue Water Navy, Korean DMZ and Thailand veterans, and H.R. 5649, which would significantly improve the transition from military service to civilian life. Improving health care for veterans, ending sequestration, and establishing full concurrent receipt were also top talking points for committee members.

VFW National Commander Meets Top Leaders:

While in town for the Fall Legislative Conference, VFW National Commander B.J. Lawrence was able to meet with a number of top Department of Veterans Affairs and military leaders, to include VA Secretary Robert Wilkie, Army Secretary Dr. Mark Esper, Army Chief of Staff Gen. Mark Milley, Air Force Director of Staff Lt. Gen. Jacqueline Van Ovost, Under Secretary of the Navy Thomas Modly, and Assistant Secretary of the Navy for Manpower and Reserve Affairs Greg Slavonic. He thanked each for their continued service to the nation, as well as communicated the VFW's numerous advocacy and support programs for veterans, service members and their families.

VFW Receives Special U.S. Flag:

The director of the Defense POW/MIA Accounting Agency (DPAA) presented the VFW one of 55 U.S. flags that draped the 55 transfer cases of American remains when they were repatriated from North Korea to American soil Aug. 1. The flag presentation is a thank you for the VFW's longstanding commitment to bring our fallen home, which included sending a letter to President Trump in advance of the June 12 Singapore Summit to urge him to include the return of American remains as a discussion point with North Korean leader Kim Jong Un. "We know for a fact that the reason President Trump brought it to Chairman Kim's attention was because of a strong letter written by the VFW," said DPAA Director Kelly McKeague yesterday, as he presented the flag and photos of the remains repatriation ceremony to VFW Executive Director Bob Wallace. DPAA lists 7,680 missing Americans from the Korean War, with some 5,300 believed to be in North Korea. McKeague said if it weren't for the strong advocacy of the VFW, the MIA issue would not have been a discussion point in Singapore, and more important, the return of the 55 cases of remains would not have happened.

New Rule Changes How VA Calculates Income for Needs-based Benefits:

VA published a final rule in the Federal Register that will establish a three year look-back period when determining eligibility for income-based benefits, including pension with aid and attendance. The new rule goes into effect on Oct. 18, 2018. It makes several changes, such as increasing the amount of net worth a veteran can have to qualify for pension, and expanding the definition of custodial care to allow veterans to deduct medical expenses for dementia care and third-party care providers. The three year look-back rule is intended to limit asset transfers done solely to qualify for governmental assistance. Such transfers may bar the veteran from receiving pension benefits, until the assets are used for their living expenses. There are some protections in place for veterans to transfer funds without a penalty, such as special needs trusts for the benefit of helpless children and helpless adult children, and trusts where the veteran retains control over the funds. Veterans can also reverse the transfer or buy back the asset in order to avoid the penalty. 
TRICARE Retiree Dental Program Update:

The current TRICARE Retiree Dental Program (TRDP) will end Dec. 31, 2018, and will be replaced by the Federal Employees Dental and Vision Insurance Program (FEDVIP) dental coverage options. Vision plans will also be available to eligible TRICARE beneficiaries through FEDVIP. The first opportunity to enroll in FEDVIP is during the 2018 Federal Benefits Open Season, which runs from Nov. 12, 2018, through Dec. 10, 2018 (EST). Coverage begins on Jan. 1, 2019. In general, retired uniformed service members and their families who were eligible for TRDP in 2018 are eligible for FEDVIP dental coverage, and if enrolled in a TRICARE health plan, FEDVIP vision coverage, beginning in 2019. Family members of active-duty uniformed service members who are enrolled in a TRICARE health plan are eligible for FEDVIP vision coverage.
