## September was Suicide Prevention Month

As we exit September, Post 7589 mourns the loss of valued comrades. The Veterans organization of the United States continues to ask and put forth guidelines to assist and support comrades struggling with life's daily challenges. This year saw a rise in suicides; while October, November,

and December don't increase incidents, many feel left out, lonely, and in despair.

The Department of Veterans Affairs (VA) empowers Veterans to connect with resources they may need now to better respond to challenges they may face later. Veterans are driven and resilient, but everyone needs help sometimes. It is not always easy to ask for help, but there are some people who will want to listen.

If you are having a difficult time, the VA encourages you to reach out for peer-to-peer support, clinical care, or counseling.

#### **Finding Support**

If you are looking for peer-to-peer support, clinical care, counseling, or something else, you can reach out in the following ways:

Call, text, or email a friend or family member to ask for support through a tough time. Veterans can find ways to get started on REACH OUT.

Connect with a fellow Veteran to talk about what they are going through.

Use these resources to find support through life challenges:

VA Solid Start: Qualified Solid Start representatives will call Veterans three times in their first year of separation to walk through the benefits available to them.

MyVA411: Veterans, their families, and caregivers can call 1-800-MyVA411 (800-698-2411) to easily access information on VA benefits and services.

Make the Connection: More than 600 Veterans and family members from across the country have shared their stories of strength and recovery. It only takes a few seconds to find a story to which Veterans can relate.

SAMHSA Behavioral Health Treatment Services: This tool, which is confidential and anonymous, allows people to search by ZIP code for local treatment facilities that focus on substance use/addiction and/or mental health issues.

Self-Check Assessment: People cope with stressful situations in different ways. This confidential, anonymous risk assessment can show if stress and depression are affecting Veterans.

National Call Center for Homeless Veterans: Veterans who are

# World War II veteran describes experience

Seventy-five years ago, Ernest Merle Hancock joined the United States Army Air Forces. The World War II veteran and Manassas resident told What's Up Prince William about his experience. In the years that followed his enlistment, Hancock embarked on several missions.

"We flew in such places as Germany, France, Czechoslovakia, Yugoslavia, and Romania," the 94-year-old said.

Hancock, a technical sergeant, was a turret gunner and flight engineer on a B-17 Flying Fortress. Ploesti, Romania was the most difficult target. "It was the largest oil refinery in the world, so it was better protected than anything else in the world," Hancock said.

However, it was his 37th mission that changed the course of his military career. On June 18, 1944, 200 German fighter aircrafts confronted Hancock's unit. "I was fortunate enough that I shot down three Focke-Wulf 190 and Me [Messerschmitt Bf] 109s, and today I hold a Silver Star for that," Hancock said. The attack forced him to parachute from 23,000 feet.

Soon afterward, the German Gestapo caught and interrogated Hancock, who was placed in the Stalag Luft IV Prisoner of War Camp. As Allied forces made progress toward the camp in February 1945, the prisoners were expected to march until they were freed two months later.

Because of his bravery, Hancock earned the Silver Star, the third-highest honor for military members. He received the Silver Star and a commending resolution from the Virginia General Assembly in March 2014.

Merle Hancock, a life member of Francis Cannon Post passed away peacefully in his sleep at the home of his daughter in Manassas on September 18th.

Merle was a WWII veteran who was awarded the Silver Star, the nation's third highest decoration for heroism, the Purple Heart, and four Air Medals. On his thirty-fourth mission, as a top turret gunner, over Germany, Merle's B-17 aircraft was shot down and he was taken prisoner. T/Sgt. Hancock would spend nine months as a POW in Stalag Luft IVB before being liberated in May 1945. Prior to being liberated he and other POWs were marched for over two months through Poland and Germany in an attempt to keep he and others from being liberated.

Merle often spoke to schools, and veterans groups about his experiences as a Prisoner of War. He never refused a request and enjoyed spending time with fellow veterans. He will be missed by all of us who knew him.

## Va. World War II vet gets Silver Star, 70 years later

A World War II veteran received a coveted military honor Friday for his actions in combat 70 years ago.

Perhaps compensating him in some degree for the tardiness of the award, the ceremony occurred on the floor of the Virginia House of Delegates.

Ernest Merle Hancock, 89, of Manassas was a B-17 turret gunner in

the Army Air Forces, the predecessor of today's Air Force, on July 18, 1944, when his plane was severely damaged and set afire in an attack by enemy fighters on a bombing mission over Germany. Despite being wounded, he shot down three attacking aircraft before bailing out.

He was approved for a Silver Star, the third-highest

award for gallantry in combat, but because of an administrative error was never notified of that fact and was not presented the medal until Friday.

Del. Richard Anderson, R-Prince William County, a retired Air Force colonel, participated in the ceremony.

Surrounded by family, Hancock rose from his wheelchair to accept the medal and received a prolonged ovation from the 100 delegates. (Continued from page 3)

The citation for Merle's Silver Star Medal reads as follows:

"On 18 July 1944, Sergeant Hancock participated in a bombing mission against a vitally important enemy airdrome in Germany. In the target area his group was attacked by approximately two hundred (200) aggressive enemy fighters, and, in the ensuing engagement, his aircraft was severely damaged and set on fire, and Sergeant Hancock was severely wounded about the legs. Despite intense pain, shock and loss of blood, Sergeant Hancock gallantly remained at his guns in the heroic defense of his crippled aircraft against the overwhelming enemy attacks. With outstanding skill key successfully destroyed three (3) of the attacking aircraft. Even when flames from the burning aircraft menaced is safety and inflicted severe burns on his legs and hips, Sergeant Hancock courageously remained at his post in the defense of his plane. Only when ordered to abandon the burning aircraft did Sergeant Hancock leave his guns and bail out."

#### WARREN EWELL—AN APPRECIATION

About 11 years ago I was working in the old office (before the renovation) at the Post. I looked outside and noticed a guy walking down the street who was wearing an American flag bandana. So I went outside, ascertained that he was a veteran and invited him inside for a soda. During the conversation I offered him the op-

portunity to become a
VFW member and because he was in financial
straits offered to pay his
1st year's dues.

Well, that guy was Warren Ewell who went on to become an active member of our Post, a Bingo caller, chair of the Americanism Committee and eventually a life member.

He credited the VFW with helping him to turn his life around. He was so grateful that he arranged his work schedule so that he could be available to work Bingo on Wednesdays.

The Joint Leadership Council for Veteran Service has seven initiatives. The first three will resonate with members of the Post.

Initiative #1 is to better resource state programs to prevent suicide.

Initiative #2 was written by me and equalizes benefits provided to surviving spouses of those killed in action by enemy and surviving spouses of 100% VA disabled by adding a provision for those spouses to

receive property tax relief if their military spouse died while on active duty and was determined to be in the line of duty.

The third is a provision to correct the law from last summer that could criminalize our honor guards and funeral firing partners as being part of an "illegal militia."

We will keep you informed to contact legislators in the state starting in December.

Tab 7, Youth & Voice of Democracy


Many of our community service events fall into several categories but only one can be chosen.

# VA offers airborne hazards, burn pit registry

Department of Veterans Affairs officials developed the Airborne Hazards and Open Burn Pit Registry to help service members and veterans document potential exposure to airborne hazards while serving overseas.

The registry is a secure database of health information voluntarily provided by service members and veterans that helps VA collect, analyze, and report on health conditions that may be related to environmental exposures experienced during deployment.

As part of the registry, service members and veterans can participate in an optional medical exam to discuss their health with a care provider. Participation in the registry will not affect access to health care or benefits, and it is not related to the VA disability compensation claims process.

"In addition to encouraging eligible service members and veterans to register, we are working across the Military Health System and in collaboration with VA to make it easier for health care providers to access patients' environmental exposure data and assess their health concerns," said Steve Jones, Force Readiness and Health Assurance Policy director and a retired Army environmental science and engineering officer. "Through all these efforts, we'll continue to collect critical data and gain a better understanding of how airborne hazards impact our troops' short-and long-term health."

#### **Eligibility**

VA staff determine eligibility for the registry based on deployment information from the Department of Defense. Service members and veterans who deployed to the Southwest Asia theater of operations on or after Aug. 2, 1990, or in Afghanistan or Djibouti on or after Sept. 11, 2001, may be eligible to sign up for the Airborne Hazards and Open Burn Pit Registry.

These regions include the following countries, bodies of water and the airspace above these locations: Afghanistan; Bahrain; Djibouti; Gulf of Aden; Gulf of Oman; Iraq; Kuwait; Oman; Qatar; Saudi Arabia; United Arab Emirates; and waters of the Arabian Sea, Persian Gulf, and Red Sea.

### How to participate

- 1. Obtain a Premium DS Logon Level 2 account. To obtain or upgrade a DS Logon account, visit the DMDC Identity Management website. Visit the DS Logon Frequently Asked Questions for assistance.
- 2. Go to the registry website and use your DS Logon to access the registry. Once logged in, verify and/or edit eligible deployment history.
- 3. Complete and submit the online questionnaire, then save and print your completed questionnaire for your records.
- 4. If interested, schedule an in-person medical exam to discuss your health with a doctor.

# Disability claims processing begins for some particulate matter conditions

WASHINGTON -- The Department of Veterans Affairs began processing disability claims Aug. 2 for asthma, rhinitis and sinusitis on a presumptive basis based on presumed particulate matter exposures during military service in Southwest Asia and certain other areas if these conditions manifested within 10 years of a qualifying period of military service.

VA conducted the first iteration of a newly formed internal process to review scientific evidence to support rulemaking, resulting in the recommendation to consider creation of new presumptions of service connection for respiratory conditions based on its evaluation of a National Academies of Science, Engineering and Medicine report and other evidence.

The process concluded that particulate matter pollution is associated with chronic asthma, rhinitis and sinusitis for veterans who served in the Southwest Asia theater of operations beginning Aug. 2, 1990 to the present, or Afghanistan, Uzbekistan, Syria or Djibouti beginning Sept. 19, 2001 to the present. VA's review also concluded that there was sufficient evidence to presume that these veterans have been exposed to particulate matter.

VA will conduct outreach to impacted veterans and survivors to inform them about their eligibility and will provide information on how to apply. Veterans and survivors who believe they may be eligible for the newly established presumptive conditions are encouraged to apply. They should file a VA Form 21-526EZ if applying for the first time or a VA Form 20-0995 if they are reapplying for these conditions. # 6 in 10 retirees have incorrect information in DEERS

When TRICARE officials tried reaching a group of retirees with critical information recently, more than 6 out of 10 had incorrect information in DEERS.

To maintain medical benefits and receive crucial health care and benefit communications, retirees and surviving spouses must maintain accurate information in the Defense Enrollment Eligibility Reporting System.

Beneficiaries need to update their information in DEERS so that health care teams can contact people with critical healthcare and appointment information; vital authorizations; claims; and enrollment information.

Retirees and surviving spouses enrolled in any TRICARE plan

need to update DEERS as soon as possible anytime they move, change contact information, or experience a qualifying life event such as:

Change in sponsor's status

Having a baby or adopting

There is a change in a student's full-time enrollment status

Becoming eligible for Medicare

Death of sponsor or family member

Marriage or divorce

DFAS is rolling out the use of status notifications to keep customers in the loop as forms or documents they submit move through the retired pay or annuitant pay processing cycles.

Status notifications are a three-step process that updates customers when DFAS receives forms or documents for processing by mail or fax, or in some specific cases, through AskDFAS. Customers will receive separate status notifications when their form or document is:

- 1. Received and queued in the DFAS work system
- 2. Assigned to be worked
- 3. Completed, with either a notification that processing is complete or a notification that DFAS is sending a request for additional information.

To be eligible to receive status notifications, customers should ensure their email address is available and updated in myPay. To add or ensure an email address is up-to-date, visit myPay.

The first rollout of status notifications involved submissions related to the Survivor Benefit Plan, including the DD 2656-6 for SBP changes and the DD 2656-7 SBP annuity startup form, as well as school certifications, the direct deposit form-SF 1199, and change of address requests. These were followed by requests related to federal tax changes (for retirees or annuitants), state tax changes (for retirees) and the designation of beneficiary for arrears of pay. Status notifications for additional categories of requests will be added throughout the coming year.


