Unclaimed Cremated Remains of Veterans:

Goal:

Members of our Legislative Team meet in Richmond on January 19th.

Facilitate the honorable burial of the unclaimed

cremated remains (cremains) of Virginia Veterans in a state veterans cemetery by requiring funeral homes to provide the name of unclaimed cremains to the Department of Veterans Services (DVS). DVS will screen the names to determine eligibility for burial in a state veteran's cemetery.

Status: Supported by Governor McDonnell.

Notes: Currently the Code of Virginia allows the funeral homes to dispose unclaimed cremains after 90 days. There is not a requirement for the funeral home to provide the names of the unclaimed cremains to the DVS for determination of veteran status. The Assembly and Senate bills will require the funeral homes to provide the names to the DVS for verification of veteran status. Once the veteran status has been established, the cremains will be turned over to the DVS for an honorable burial.

Sales and Use Tax Exemption for Veterans Service Organizations:

Goal: Recognize the community service and philanthropic contributions of Virginia's Veterans Service Organizations (VSOs) by establishing an exemption for VSOs from local Sales or Use Taxes.

Status: Not supported by Governor McDonnell. No further action pending

Notes: The IRS has nationally organized and rec-

ognized VSOs as exempt from federal income tax under section 501 (c)(19) of the Internal Revenue Code. The Code of Virginia provides an exemption for sales and use taxes for 501 (c)(3) or 501 (c)(4) organizations. The VSOs classified as 501 (c)(19) perform the same functions as the 501 (c)(3) or 501 (c)(4) organizations. During the year 2010, the VA VFW (both Comrades and the Ladies Auxiliary) reported the expenditure of \$1,852,292 and a donation of 339,052 in volunteer hours. This resulted in over \$4.5 million in support of youth and community activities.

Many of the VSOs were 501 (c)(3) or 501 (c)(4) organizations before they became 501 (c)(19) organizations. We are not asking for anything "new", just what we had prior to the new section 501 (c)(19). The exemption would free sales and use taxes on fuel, maintenance, cleaning, office supplies, and other items not for resale. Thus would put all VSOs on an equal basis with the 501 (c)(3) or 501 (c)(4) organizations.

Budget Objectives:

Homeless Veterans:

Goal: Reduce and prevent veterans homelessness in Virginia by implementing as many strategies identified in the Joint Legislative Audit and Review Commission (JLARC) 2010 study as state fiscal resources will allow.

Status: Governor McDonnell's introduced budget includes \$197,018 and two Homeless Veterans Coordinator positions.

Notes: a 2010 "Point in Time" survey of homeless veterans put the number of homeless veterans in Virginia at 995. Trends reported by US Department of Veterans Administration (USDVA), veterans advocacy groups, and social services agencies show a significant increase in the number of woman veterans among the homeless. Also, there are trends showing the Iraq and Afghanistan veterans are becoming homeless at a faster rate than veterans of previous conflicts.

Veterans Identification:

Goal: Provide a simple, ready means of identification of veteran status for Virginia's veterans by creating a Virginia Veterans ID Card.

Status: Supported by Governor McDonnell. Under development by DMV. Target rollout is Memorial Day, 2012.

Notes: *Veterans who have served in the active military, naval, or air service and who have been released under condition "other than dishonorable" could qualify for the VA Veteran's ID Card. This card would provide a quick and convenient way to prove their veteran status; allow the veteran to qualify for the discount which merchants offer; qualify for other cost saving features such as free access to Virginia's parks and/or reduced fishing license fees; and honor the service of a veteran to Virginia and the Nation.*

There are several bills in front of the General Assembly. Look at the matrix regarding the bills—we will keep you updated via the Post website, www.vfw7589.org.
