#### VIETNAM MOMENTS / PRE-DRAFT PHYSICAL

We all remember. Your first real taste of the military. The pre-induction or pre-draft physical.

I was a teacher at Greenwood High School in rural southern Delaware in May of 1969 when I received my notice.

You had to have some doubts. I wanted to serve my country but a year before, President Lyndon Johnson had announced he was not running for re-election and, basically, declared the Vietnam War a lost cause. Who wanted to be the last man to die in a "lost cause?"

But I had always supported our general aims in the war (to contain the spread of communism in Southeast Asia), so I showed up at the courthouse in Georgetown, Delaware on a beautiful spring morning and got ready to board a school bus for the long ride to Philadelphia. Standing there with me were about 60 other guys and I felt old. I was 22, a college graduate with nearly a year of classroom teaching under my belt. These other guys were 18 or 19 and just out of high school.

But they all looked like Class A athletes. I immediately started to worry about the ride back if I flunked this physical.

Some gallows humor. One of the guys on the bus read aloud from a newspaper about a battle in Vietnam where 50 Viet Cong were killed but nine Americans also died. There were some chuckles but a lot of silence.

When we arrived at the induction center in Philly, things moved fast. I remember a black guy walking around in a colorful, flowing dashiki. I remember a guy with much thicker, uglier glasses than mine calling me "four eyes." I remember spending most of the day in various stages of undress and having just every part of my body poked or prodded at. There was diabetes in my family which meant some especially painful blood tests. There was a big room where about 200 of us stood naked while a group of doctors walked up and down the rows. A humbling day. But I passed the physical.

On the way back, we stopped at a huge bus terminal outside Wilmington where we had dinner courtesy of Uncle Sam. As we ate together, things loosened up and to my amazement I found out about 75 percent of these guys, these youthful, well built jocks, had flunked the physical. Letters from doctors were produced, written pleas from psychologists and ministers, even some letters from politicians.

As I drove back to my rented room that night, I had mixed feelings. I was proud to be fit for duty but felt kind of stupid and naive I hadn't focused on all these ways to get out of the draft. It was the start of a Vietnam journey and a war where a lot of issues were less than clear.

#### Study Focuses on Combat-related Nightmares

Madigan Army Medical Center is conducting a first-of-its-kind study on reducing combat-related nightmares among returning Soldiers from Iraq and Afghanistan. Researchers are looking into an inexpensive, generic drug called Prazosin to help Soldiers get better restorative sleep. Only active-duty service members can participate in the study at Madigan. A separate study is being conducted at VA Puget Sound for Operation Iraqi Freedom and Operation Enduring Freedom veterans who are no longer on active duty. #### House Reviews Appeals Process

The House Veterans' Affairs Disability Assistance and Memorial Affairs Subcommittee recently conducted a hearing to continue its oversight of the Board of Veterans' Appeals (BVA), the Appeals Management Center (AMC), and the U.S. Court of Appeals for Veterans Claims (CAVC). The hearing focused on the efficiency and effectiveness of the agencies tasked with handling appeals filed by veterans pertaining to claims for benefits initiated at the Department of Veterans Affairs (VA). At the hearing, members heard the frustrations that veterans and survivors encounter waiting months and years on an appeal decision. The reissued stamp features a photograph by Ira Wexler of one of two Purple Hearts awarded to James Loftus Fowler of Alexandria, Va., who was battalion commander of the Third Battalion, Fourth Marines serving in Vietnam. 
